### **Gaiam (NASDAQ: GAIA) and MCSI (NASDAQ: MCSI) OPS Alert**

**March 3, 2003**

Gaiam (NASDAQ:GAIA) AND MCSI (NASDAQ:MCSI), both featured in the February 25, 2003, Issue (26) of the OPS Newsletter declined by 30% and 60% respectively last week. The declines Occurred in the same week that both companies were mentioned in the OPS Newsletter with MCSI'S shares closing at \$1.58 and Gaiam's at \$6.70 on the day that they were both named as OPS Kindling. On the very next day (Wednesday, February 26th) MCSI shares tumbled to \$.71 on over six million shares of trading volume after it annouced that it had lost over \$220 million for fiscal 2003. Three days later (Friday, February 28th) Gaiam's shares tumbled tp \$4.52 on significant trading volume after it reported fiscal 2003 results. The shares for both companies hit all time new lows last week.

GAIAM was originally named as an OPS Warning in [Issue 10](#) with a follow on alert being issued on [January 17th](#). MCSI was named as an OPS Warning in [Issue 3](#) with a follow up in [Issue 18](#).
